

Dear Students / Parents

We are glad to inform you that from the current academic year i.e. 2011 -12, starting from 17th August 2011, your University is going to provide on line learning in a very comprehensive manner i.e. through the media of Video conferencing, E. books, Virtual class rooms, very vast E. library. After becoming active member of National Knowledge Network, your University is in a position to considerably enhance its capacity to provide quality higher education at the door steps of the students.

From the current session your University is also planning to enter into placement support arrangements with various industrial houses, potential employers and employment support providers. Your University has already started revising syllabus for various courses keeping in mind the requirements of potential employers in India and abroad. This exercise is being done in consultation with industry and also in accordance with well established practices in well known Indian and foreign Universities.

You may also be aware that Govt. of India is in the process of making far reaching and very comprehensive reforms in our higher education system

and to achieve, it has already introduced number of Bills in Parliament and some more are likely to be introduced in forthcoming monsoon session. We are therefore restructuring our functioning accordingly; we sincerely hope this will enhance quality of education in a substantial way.

To make your University educational facilities, accessible to all we have considerably reduced and rationalized our fee structure. Provisions have been made to provide fee concessions and scholarship to needy and meritorious students. University is also going to make available all possible support to the students for obtaining Bank loans which are interest free and without any security and scholarships by Social Welfare departments of various states. Central Government, UGC and State Government have got various schemes for grant of scholarships to S.C, S T, Minorities, BPL and meritorious students and also for Research.

Since the current session is going to start from 17th August 2011, students are advised to make payment of fee payable by them in the University Account as mentioned below by 10th August 2011 to avail the benefit of reduced fee. Those students who are not in a position to make payment of full annual

fee, they can make payment of one semester fee and post facto can apply to the University for grant of such facility of making semester wise fee payment. Those students who are entitled for fee concessions or Scholarship, can also apply for grant of the same to the University those students, who make payment of their fee by the above mentioned date i.e. 10th August 2011 shall be entitled to receive free of cost a set of text books other than educational material, sports goods and note books etc. etc. worth Rs 5000/- or more. Those who fail to do so, their names shall be struck off with immediate effect.

Students who opt to be Online students or In service students are entitled for fee concession benefits of reduced fees and 10% of fee paid as refund.
